

Other Desirable Outcomes


- Long-term serviceability of corridor
- Maximize public investment in corridor
- Better integration of the interstate with the urban environment

We should be looking at a tunnel






Project doesn't solve congestion




 I-84 Hartford is connected to other transportation initiatives

More Comprehensive Approach

- Prudent to take holistic approach to interlocking challenges
- Now is best opportunity to expand our vision
- Further benefit for City of Hartford and entire region






How do we look at this holistically?

- Continue under NEPA
 - Cumbersome
 - Time-consuming
- Conduct a Planning Environmental Linkage (PEL)
 - More efficient planning tool





84 What went into this decision?






Greater Hartford Mobility Study

Consider many factors to complete the vision of mobility for the next century

- State of good repair
- Safety
- Rail and transit
- Traffic and congestion
- Bicycle and pedestrian
- Connectivity for all users





How does this change the start of any construction?

- Previous I-84 Harford schedule
- Funding only through ROD
- Study complete in 2-3 years
- Opportunity for projects out of the study sooner





84 Next Steps





What happens to the I-84 Hartford Project?

- Rescind the Notice of Intent
- Suspend work on I-84 Hartford EIS
- I-84 Hartford Project becomes part of the Greater Hartford Mobility Study
 - Current NEPA and engineering work will not be lost



Next Steps for the Greater Hartford Mobility Study

- Funding for study is available
- Determine scope of work
- Develop outreach program
- Prepare project milestones and schedule





Next Steps for I-84 Hartford PAC

- Public outreach will inform the Greater Hartford Mobility Study
- Members of the I-84 Hartford PAC will continue to play an integral role in the new study
- Outreach will expand to include new stakeholder groups within the new study limits
